CONDITIONS OF PARTICIPATION

In general, the conditions of participation of the International Logboat Regatta 2023 follow the conditions of participation and safety regulations of the "Internationale Bodenseewoche 2023". (The "International Bodenseewoche" regulations apply. The DRV/DKV or other association competition rules do not apply).

The referees will be provided by ADIWA Nautic GmbH.

The decision of the referees is binding.

The course will be secured by dinghies of the organisers of the Internationale Bodenseewoche and the water police. Due to weather conditions it may be necessary to change the course of the above mentioned logboat regatta. The decision of the routing is incumbent on the regatta management.

The route will be communicated to the teams by the race director, ADIWA Nautic GmbH, before the start of the race and the safety concept will be explained.

Each participant must be able to swim.

Each participant must wear a life jacket, which will be provided on site.

The minimum age is 16 years. Participants under 18 years of age must have a declaration of consent from their legal guardian(s) before the competition, which must be signed by the legal guardian(s) and the participant. The legal guardian(s) must sign a declaration that the participant is able to swim.

Type of boat: replicas of logboats from the Neolithic period, provided with paddles.

Scoring: without consideration of age and gender

LIABILITY

The responsibility for a skipper's decision to enter or continue in a race rests solely with the skipper, and to that extent the skipper also assumes responsibility for his/her crew. The skipper is responsible for the fitness and proper seamanship of his crew.

In cases of force majeure or due to official orders or for safety reasons, the organiser is entitled to make changes to the implementation of the event or to cancel the event. In such cases, the organiser shall not be liable for damages to the participant.

Any liability of the organiser, irrespective of the legal grounds, for property damage and financial losses of any kind and their consequences which the participant suffers during or in connection with participation in the event as a result of conduct on the part of the organiser, its representatives, vicarious agents or representatives, shall be limited to damage caused intentionally or by gross negligence in the event of a breach of obligations which are not primary obligations or obligations essential to the contract (cardinal obligations).

In the event of a breach of cardinal obligations, the liability of the organiser in cases of simple negligence shall be limited to foreseeable, typically occurring damage. Insofar as the organiser's

liability for damages is excluded or limited, the participant shall also exempt from personal liability for damages the employees - workers and staff - representatives, vicarious agents, sponsors and persons who provide, drive or assist in the use of towing, safety or recovery vehicles, as well as all other persons who have been commissioned in connection with the implementation of the event.

INSURANCE/DAMAGE

Insurance is the responsibility of the participants. Participation is at the participant's own risk. The organiser accepts no liability (including negligence) for personal injury and/or damage to property of any kind (including consequential damage) arising in connection with the event.

IMAGE AND SOUND RIGHTS

Participants waive any rights to their own image. They declare their consent to the unrestricted and free use of image and sound recordings by the organiser.

ORGANISER

The organiser of the International logboatregatta 2023 is the Förderverein Pfahlbau-Welterbebestätte Litzelstetten-Krähenhorn e.V. The Förderverein has delegated individual tasks to partners, supporters and service providers.
